#### **Notification of change of Investment Manager**

Following a recent strategic review, Perennial Investment Partners Limited (Perennial) has decided to exit the management of global equities via the sale of the Perennial International Equities Management boutique to Pinnacle Investment Management Limited (Pinnacle).

As a result of this decision, IOOF Investment Management Limited (IIML), the responsible entity for the Product Name Trust (the Trust), has entered into an agreement with Pinnacle International Equities Limited (Pinnacle International) to take over the investment management of the Trust effective from 1 December 2014. Under the terms of the agreement, members of the Perennial International investment team will transfer to Pinnacle International and continue to manage the Trust in accordance with the current investment strategy.

From 1 December 2014, the Trust will be renamed the Pinnacle Global Shares High Alpha Trust.

There will be **no change** to any other product features or the investment strategy.

In addition to the investment management responsibilities to be undertaken by Pinnacle International, Pinnacle will be responsible for the distribution, marketing and client servicing of the Trust.

Pinnacle International has been recently established for the specific purpose of managing your investment and building an international equities boutique in partnership with Pinnacle.
